We have a proven track record of delivering first-class, costefficient services, which our clients know they can depend on to add value to their business.



Our Services Utility Services

- Initial enquiries and budget estimates for supplies to the site and any reinforcement costs, presented in a short report, suitable for land purchase due diligence or cost estimating.
- Utilities Statements for submission with planning applications. These are similar to the initial enquiries, but the report does not include the financial information and is composed in a 'planning-friendly' format.
- Applications for disconnections of services to existing properties.
- Applications for and **coordination of meter removals**.
- Attend site to meet and **supervise** both **disconnections** of services **and meter removals**.
- **Detailed enquiries** once planning consent has been granted and detailed designs for the site are available.



Our Services Utility Services

- Formal detailed quotations will be obtained and passed to the client for payment and calling off by site management.
- Maximize the benefits of the competitive market by obtaining quotations from other independent network operators.
- Quotations for diversions of existing mains and services required as a result of the new development, together with costs of any off-site reinforcement of the utilities network.
- Quotations for electric networks for the street lighting design, carried out by the civil engineer.
- Obtain the MPAN and MPRN numbers for the new meters for the development.
- Challenging any costs levied by the utility companies in relation to quotations which are estimates and not fixed. This work is undertaken 'at risk' and a percentage of any recovery is paid to TDSM.



Our Services Adoptions

- Working on behalf of developers to achieve adoption of roads, sewers, and open spaces.
- Management of inspections, remedial works, and issue of completion certificates.
- Liaison with NHBC and other Bond Companies to release guarantee bonds on successful adoption of roads and sewers.
